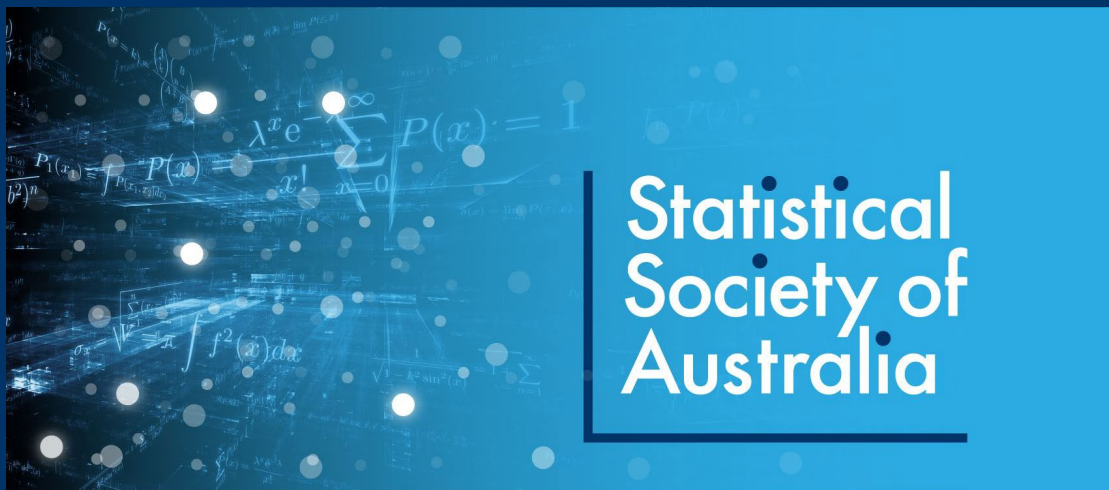

Today is "[Daffodil Day](#)". Daffodil Day first started in Canada years ago as a campaign to raise funds for cancer research and patient care. The daffodil was chosen as the emblem because of its vibrant yellow colour, symbolising optimism and the promise of a brighter future. Daffodil Day is a celebration of hope.

What started in Canada in 1957 has since spread to many countries around the world. In 1986 the NSW Cancer Council adopted the event, thus bringing Daffodil Day to Australia.

While different regions observe Daffodil Day on various dates, the core message remains the same – to stand together against cancer and work towards a world where the disease is preventable, treatable and eventually curable.

Working for the Statistical Society of Australia (SSA) I am proud to be serving all our members, but especially those involved in cancer research and the fight against this terrible disease. Thank you for the amazing work that you do.

One in two people will be affected by cancer in their lifetimes. Daffodil Day

serves as an opportunity to raise awareness about cancer prevention, early detection and available support services. Educational workshops, seminars and informational materials aim to empower individuals with knowledge about reducing their risk of cancer and recognising the importance of regular screenings.

Daffodil Day provides an opportunity for communities to unite in the fight against cancer. Schools, workplaces and local organisations often participate by organising fundraising events, awareness campaigns and selling daffodil-themed merchandise to generate funds for cancer-related initiatives. It is a day that emphasises the power of collective action and demonstrates that even small contributions can make a significant impact. In 2022, Daffodil Day raised around \$2.5 million for lifesaving cancer research.

On a personal note, our family will attend a fundraising event tonight at “Bloomhill” – a local charity that supports cancer patients, survivors and their carers. Some guests will attend to give back by bidding generously at the charity auction or buying raffle tickets, others may attend simply because they enjoy a good party! Daffodil Day is a poignant reminder of the strength of human spirit, the power of community and the importance of never giving up in the face of adversity. The [Bayesian Statistics Conference \(Bayes on the Beach\)](#) is a biennial conference held in Australia, organised by the Bayesian Research & Applications Group ([BRAG](#)) in collaboration with QUT Centre for Data Science ([CDS](#)); the Australasian chapter of the International Society for Bayesian Analysis ([ISBA](#)); the Statistical Society of Australia, ([SSA](#)) [Bayesian Statistics Section](#); and Queensland University of Technology ([QUT](#)). The conference has been held for over 15 years. They are intentionally community gatherings, run over 3 days with keynote and invited presentations, workshops and tutorials, and poster sessions. The agenda also carves out dedicated intervals for stimulating discussions, valuable networking opportunities and even moments of beach time.
